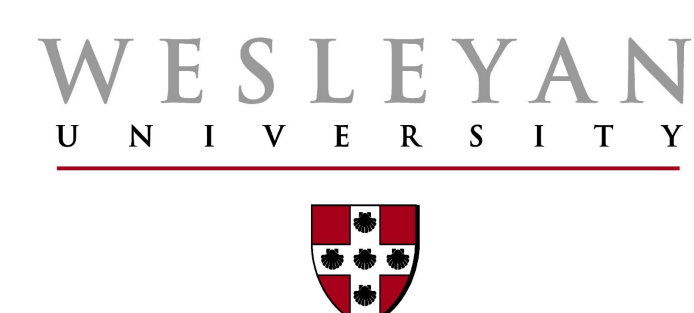

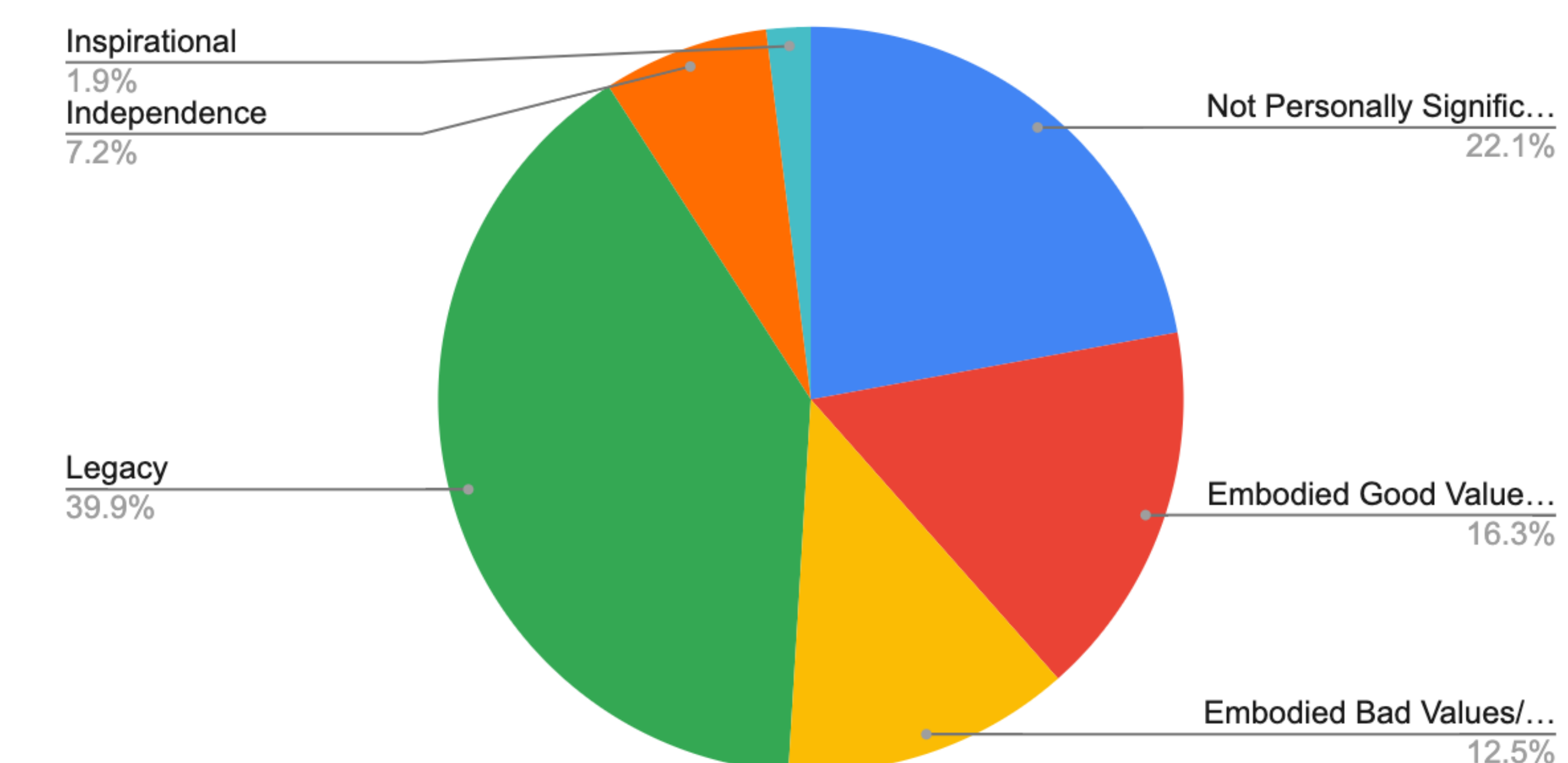

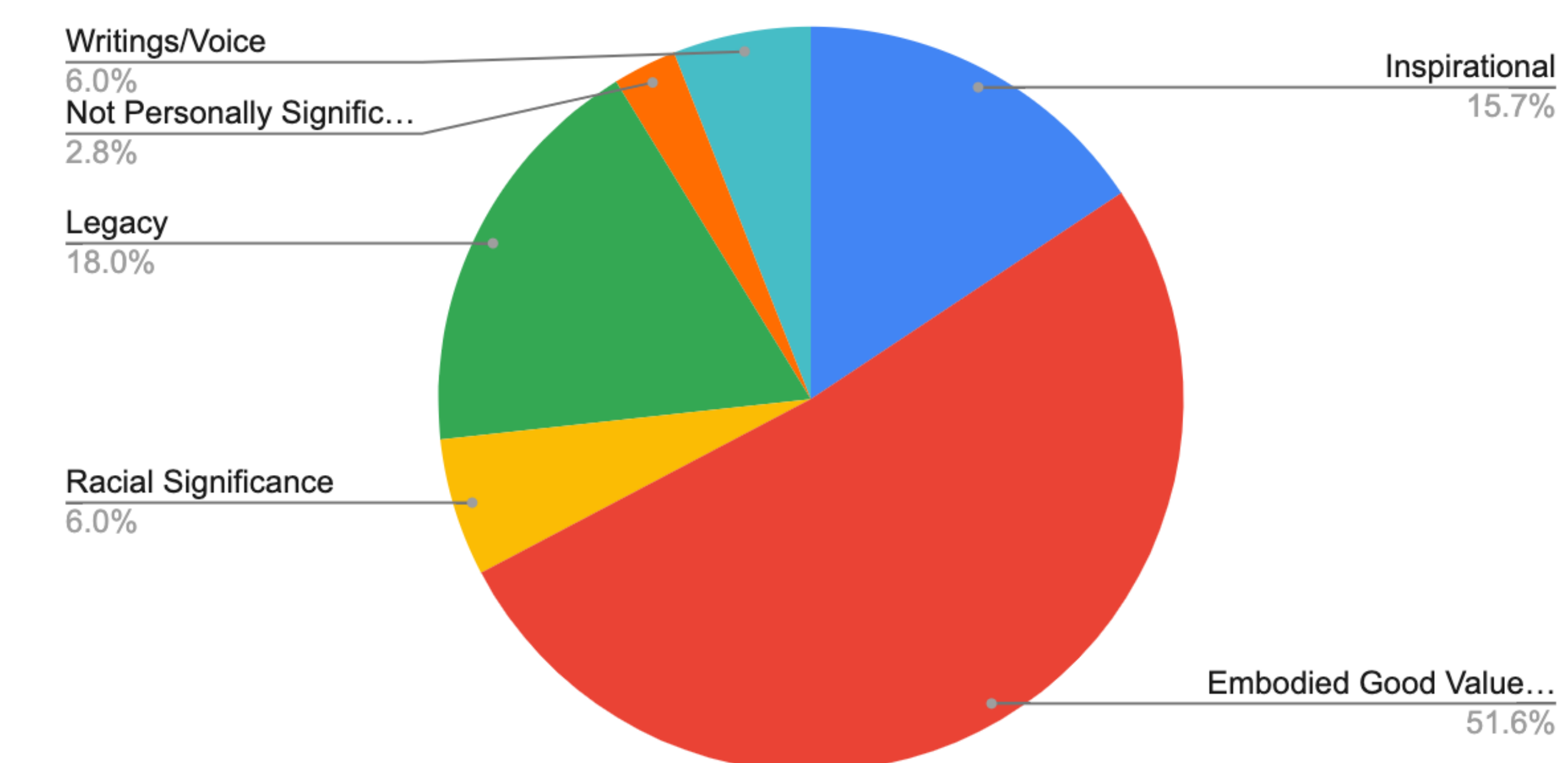

THEME	MEANING	EXAMPLE
Inspirational	Figure is a source of inspiration for participant.	"...an immense inspiration to the fight for equality in the United States." [Tubman]
Embodied Good Values/Qualities	Figure had admirable qualities/values, and/or did good things.	"He is a sign of perseverance and doing what is right." [Douglass]
Not Personally Significant	Figure holds no personal significance to participant.	"I don't find him to be very important to my life." [Jefferson]
Embodied Bad Values/Qualities	Figure had unadmirable qualities/values, and/or did bad things.	"I do not really identify with him as a person because he owned slaves..." [Jefferson]
Legacy	Figure holds historical significance and/or has had lasting impact(s).	"...without her today's America could be a far worse place, one with far less equality." [Tubman]
Independence	Figure embodies the ideal of independence.	"...important for me because he somewhat represents American ideals of freedom." [Washington]
Racial Significance	Figure's race is one reason why they are important to participant.	"...represents a strong Black woman, a person I hope to be." [Tubman]
Writings/Voice	Figure had impactful writings and/or made their voice heard.	"His novels inspired me; he is one of my favorite writers to read today." [Douglass]

INTRODUCTION

- US history is often taught through a glorified, nationalist lens (Zinn, 2015)
- Marley Hypothesis – understanding history is important for understanding racism (Bonam et al., 2019)
- Collective Memory – groups remember their past together (Halbwachs, 1992)

METHODS

Morality, Race, Nationality, and History Scales

- N* = 59 (31 male, 28 female, 0 non-binary/third gender/prefer not to say) undergraduate participants (White: 62.7%, Asian American/Pacific Islander: 13.6%, Black: 8.5%, Hispanic-American/Latino: 6.8%, Bi/Multiracial: 8.4%)
- Explanatory Variables: Attachment ($\alpha = 0.91$), Glorification ($\alpha = 0.89$), Collective Guilt ($\alpha = 0.94$), Moral Self-Image ($\alpha = 0.90$).
- Dependent Variables: Self-reported Black history knowledge (single-item variable), mean certainty of Black history knowledge ($\alpha = 0.89$), actual Black history knowledge.

Historical Figures Significance Responses

- Please think about [Thomas Jefferson, George Washington, Frederick Douglass, or Harriet Tubman]. Please describe why this historical figure is important for you.

RESULTS & DISCUSSION

- Moral self-image was related to both self-reported Black history knowledge and certainty of Black history knowledge, but not with actual Black history knowledge.
- Participants placed more importance on White figures in terms of legacy, and on Black figures in terms of good values/qualities
- Limitation: Student sample from liberal arts college
- Suggests that people with inflated moral self images could see themselves as more knowledgeable in Black history without having the actual knowledge to back up their claims
